

Mediacom Home Sweet Home Sweepstakes

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID IN ALASKA, HAWAII, AND WHERE PROHIBITED BY LAW.

EACH WINNER MAY BE REQUIRED TO EXECUTE PRIZE ACCEPTANCE DOCUMENTS AND RETURN THEM WITHIN SEVEN (7) DAYS FROM DATE OF ISSUANCE OF NOTIFICATION, AS MORE FULLY DETAILED BELOW.

BY ENTERING, YOU AGREE TO THESE OFFICIAL RULES. THESE OFFICIAL RULES ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SPONSOR (DEFINED BELOW) FROM YOU, A CLASS-ACTION WAIVER, AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

OVERVIEW: The Mediacom Home Sweet Home Sweepstakes ("**Sweepstakes**") is sponsored by Mediacom Communications Corporation ("**Sponsor**"). The Sweepstakes begins at 12:00:00 a.m. (midnight) Eastern Time ("**ET**") on July 17, 2017, and ends at 11:59:59 p.m. ET on August 15, 2017 ("**Sweepstakes Period**"). The Sweepstakes Period is divided into four (4) separate entry periods (each a "**Weekly Prize Period**"). All eligible entries received during the Sweepstakes Period will be entered into the prize drawing for the Weekly Prize Period during which the entry is received, as well as into the drawing for the grand prize. Entries for the Weekly Prize Periods are not cumulative and do not roll over into subsequent Weekly Prize Periods. Entry into one Weekly Prize Period does not constitute entry into any other Weekly Prize Period. The Weekly Prize Periods and grand prize drawing period begin and end as specified in the table below:

ELIGIBILITY: This Sweepstakes is open only to legal residents of the forty-eight (48) contiguous United States or the District of Columbia who are at least eighteen (18) years of age and the age of majority in their jurisdiction of primary residence. This Sweepstakes is void in Alaska; Hawaii; all U.S. territories (including Puerto Rico), possessions, and overseas military installations; and where prohibited by law. Corporations and other entities are not eligible to enter or win a prize in this Sweepstakes. Employees, officers, directors, members, managers, representatives, and agents of Sponsor or Scripps Networks LLC dba Home & Garden Television, their respective advertising and promotion agencies, Hothouse, Inc. ("**Administrator**"), or any other entity participating in the design, promotion, marketing, administration or fulfillment of this Sweepstakes, as well as each of their parent corporations, subsidiaries, and affiliated companies (the "**Released Parties**"), and their immediate families (defined as spouses, partners, parents, legal guardians, siblings, children, and grandparents, regardless of where they reside) and members of the same household (whether legally related or not), are ineligible to participate or win any prize in this Sweepstakes.

HOW TO ENTER: If you meet the eligibility requirements, you may enter this Sweepstakes by visiting www.mediacomhomesweethome.com (the "**Sweepstakes Site**") and following all onscreen entry instructions and links to complete and submit the Sweepstakes entry form during the Sweepstakes

Period, including providing your first and last name, email address, phone number (including area code), date of birth, and any other required information. An entry is “received” when the Sweepstakes Site’s servers actually record submission of the completed entry form. Evidence of submission (such as an automated computer receipt confirming entry or a saved or printed “thanks for entering” screen or message) does not constitute proof of actual receipt of an entry. All entries must be received by Sponsor during the Sweepstakes Period or they will be void.

THERE IS A LIMIT OF ONE (1) ENTRY PER PERSON, PER DAY. The Sweepstakes Site’s database clock will be the official timekeeper for the Sweepstakes. Any attempt by you to obtain more than one (1) entry per day by using multiple/different email addresses, identities, registrations or logins, or through any other method, may void your entries and you may be disqualified from the Sweepstakes. Entries that are forged, altered, incomplete, lost, late, illegible, unintelligible, duplicated, misdirected, mutilated, illegitimate, garbled, or generated by a macro, bot, or other automated means or submitted with intent to subvert the entry process will not be accepted and are void. Entries may not be acknowledged and will not be returned. Those who do not provide the required entry information in their entry form or abide by these Official Rules and other instructions of Sponsor and its representatives may, in Sponsor’s sole discretion, be disqualified and all associated entries voided. Entries or participation made on your behalf by any other individual or by you for another individual, made by or for any entity or group, or originating at any website other than the Sweepstakes Site (including, without limitation, through a commercial promotion subscription, notification, or entering service) will be declared invalid and void for this Sweepstakes. In the event of a dispute about the identity of an entrant, the entry will be declared made by the authorized account holder of the email address submitted at time of entry, but only if that person meets all other eligibility criteria for this Sweepstakes (failing which the entry or entries in question will be disqualified). The authorized account holder is defined as the natural person who is assigned to an email address by an online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. With respect to any winning entry, the winner may be required to provide proof that he or she is the authorized account holder of the email address associated with such winning entry. If a dispute cannot be resolved to Sponsor’s satisfaction, the entry will be deemed ineligible. As a condition of entering the Sweepstakes, each entrant gives consent for Sponsor and Administrator to obtain and deliver his or her name, address and other information to third parties for the purpose of administering this Sweepstakes and complying with applicable laws, regulations and rules.

DRAWING, NOTIFICATION, AND ODDS OF WINNING: Following the close of each Weekly Prize Period, Administrator will select one (1) potential winner in a random drawing from among all eligible entries received for that Weekly Prize Period (for a total of four (4) Weekly Prize Period drawings over the course of the Sweepstakes). Each Weekly Prize Period drawing will be conducted within five (5) business days of the close of the applicable Weekly Prize Period. Following the close of the Sweepstakes Period, Administrator will select one (1) potential grand prize winner in a random drawing from among all eligible entries received during the Sweepstakes Period. The grand prize drawing will be conducted within five (5) business days of the close of the Sweepstakes Period.

THERE IS A LIMIT OF ONE (1) PRIZE PER PERSON. No entrant may win both a Weekly Prize and the Grand Prize (as each term is defined below), nor may any entrant win more than one (1) Weekly Prize. Decisions of the Sponsor are final on all matters relating to the Sweepstakes, including interpretation of these Official Rules, determination of the winners, and awarding of the prizes. Odds of winning a prize depend on the number of eligible entries received for the applicable prize drawing. Sponsor or its representative will attempt to notify the potential prize winners by phone or email (in Sponsor’s sole discretion) within approximately five (5) business days of the applicable drawing. Each potential prize winner may, in Sponsor’s sole discretion, be required to complete, sign, have notarized (if applicable) and return an Affidavit of Eligibility and Liability/Publicity Release (unless prohibited by law) and tax documents, if applicable (collectively, “**Prize Winner Documents**”), any or all of which may require the potential winner to provide his or her Social Security Number, and a copy of a government-issued identification or number thereof, within the time frame specified and in the form provided by Sponsor, without revision, or prize may be forfeited. The Prize Winner Documents, if applicable, must be received by Sponsor within seven (7) days of Sponsor sending the documents to the potential winner or other time

frame as stated in the Prize Winner Documents or prize may be forfeited and an alternate winner may be selected. Sponsor reserves the right to modify the notification procedures in connection with the selection of any alternate potential winner. Entries, prize claim, and Prize Winner Documents are subject to verification by Sponsor. The prizes, if legitimately claimed, will be awarded. Sponsor will not be obligated to pursue more than three (3) alternate winners (time permitting) for each prize for any reason, in which case the applicable prize may go unawarded. In the event of a dispute about the identity of an entrant, Sponsor will settle the dispute in its sole discretion and Sponsor's decision will be final and may involve disqualifying all disputed entries.

PRIZE DETAILS & APPROXIMATE RETAIL VALUE ("ARV"):

Grand Prize: The one (1) grand prize winner will receive a prize consisting solely of one (1) two thousand dollar (\$2,000) American Express prepaid card ("**Grand Prize**"). ARV of Grand Prize: \$2,000.

Weekly Prizes: The one (1) winner for each Weekly Prize Period will receive a prize consisting solely of one (1) two hundred and fifty dollar (\$250) American Express prepaid card (each a "**Weekly Prize**"). ARV of each Weekly Prize: \$250.

Total ARV of all prizes available in the Sweepstakes: \$3,000.

Prepaid cards are subject to additional terms and conditions as imposed by their issuer and as specified on the card or in its accompanying materials. All prize details not specified in these Official Rules will be determined by Sponsor in its sole discretion. If Sponsor determines, at any time and in its sole discretion, that any winner or potential winner is disqualified, ineligible, or in violation of these Official Rules, Sponsor reserves the right in its sole discretion to disqualify that person and select an alternate winner, even if the disqualified winner or potential winner's name may have been shown or announced. Sponsor reserves the right to substitute any of the stated prizes, or any portion thereof, with another prize of equal or greater value for any reason, including, without limitation, unavailability of the stated prize. All taxes (federal, state, or local) and all other costs and expenses associated with prize acceptance or use and not specified in these Official Rules as being part of a prize will be the sole responsibility of the applicable winner. Each winner may be issued a 1099 tax form for the actual value of his/her prize. No more than the stated prizes will be awarded. THE PRIOR LIMITATION ON DAMAGES IS NOT INTENDED TO LIMIT THE RELEASED PARTIES' OBLIGATION (IF ANY) TO PAY PREVAILING PARTY COSTS OR FEES IF RECOVERABLE PURSUANT TO APPLICABLE LAW. THE

LIMITATIONS SET FORTH IN THIS SECTION WILL NOT LIMIT OR EXCLUDE THE RELEASED PARTIES' LIABILITY FOR PERSONAL INJURY OR TANGIBLE PROPERTY DAMAGE CAUSED BY THE RELEASED PARTIES, OR FOR THE RELEASED PARTIES' GROSS NEGLIGENCE, FRAUD, OR INTENTIONAL, WILLFUL, MALICIOUS, OR RECKLESS MISCONDUCT.

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, EACH WINNER AGREES THAT THE PRIZE WON IS PROVIDED AS-IS WITHOUT ANY WARRANTY, REPRESENTATION, OR GUARANTEE, EXPRESS OR IMPLIED, IN FACT OR IN LAW, WHETHER NOW KNOWN OR HEREINAFTER ENACTED, RELATIVE TO THE USE OR ENJOYMENT OF THE PRIZE, INCLUDING, WITHOUT LIMITATION, ITS QUALITY, MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE.

EACH ENTRANT UNDERSTANDS AND AGREES THAT ALL RIGHTS UNDER SECTION 1542 OF THE CIVIL CODE OF CALIFORNIA AND ANY SIMILAR LAW OF ANY STATE OR TERRITORY OF THE UNITED STATES ARE HEREBY EXPRESSLY WAIVED BY HIM/HER. SECTION 1542 READS AS FOLLOWS:

"CERTAIN CLAIMS NOT AFFECTED BY A GENERAL RELEASE. A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR."

ADDITIONAL DISCLAIMERS: Without limiting any other provision in these Official Rules, Released Parties are not responsible or liable to any entrant or winner (or any person claiming through such entrant or winner) for failure to supply a prize or any part thereof in the event that any of the Sweepstakes activities or Released Parties' operations or activities are affected by any cause or event beyond the sole and reasonable control of the applicable Released Party (as determined by Sponsor in its sole discretion), including, without limitation, by reason of any acts of God, equipment failure, threatened or actual terrorist acts, air raid, act of public enemy, war (declared or undeclared), civil disturbance, insurrection, riot, epidemic, fire, explosion, earthquake, flood, severe weather, blackout, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, any law, rule, regulation, action, order, or request adopted, taken, or made by any governmental or quasi-governmental entity (whether or not such governmental act proves to be invalid), or any other cause, whether or not specifically mentioned above. Released Parties assume no responsibility and will not be liable for any of the following, whether caused by a Released Party, the entrant, or by human or other error: lost, late, incomplete, misdirected, stolen, garbled, unintelligible, or illegible entries or postage-due mail; address changes of entrants or entries not received in accordance with these Official Rules; viruses or technical or mechanical malfunctions; interrupted or unavailable cable or satellite systems; technical, hardware or software malfunctions of any kind, or unavailable network or Internet service provider connections; failed, incorrect, inaccurate, incomplete, garbled, or delayed electronic communications; errors, typos or misprints in these Official Rules, in any Sweepstakes-related advertisements or other materials; failures of any of the equipment or programming associated with or utilized in the Sweepstakes; unauthorized human and/or mechanical intervention in any part of the entry process or the Sweepstakes; or technical or human error which may occur in the administration of the Sweepstakes or the processing of entries. Sponsor reserves the right, at its sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of this Sweepstakes, or to be acting in violation of these

Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to annoy, abuse, threaten, or harass any other person. If any person supplies false information, obtains entries by fraudulent means, or is otherwise determined to be in violation of these Official Rules in an attempt to obtain any prize, Sponsor may disqualify that person and seek damages from him or her and that person may be prosecuted to the full extent of the law. If any provision of these Official Rules is held unlawful, void, or for any reason unenforceable by a court of competent jurisdiction, then that provision shall be deemed severable from these Official Rules and shall not affect the validity and enforceability of any remaining provisions. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules will otherwise remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to insist upon or enforce strict performance of any provision of these Official Rules shall not be construed as a waiver of any provision or right. No waiver of any term or condition of these Official Rules shall be deemed a further or continuing waiver of such term or condition or any other term or condition. In the event of an alleged or actual ambiguity, discrepancy or

inconsistency between disclosures or other statements contained in any Sweepstakes materials and the terms and conditions of these Official Rules, it will be resolved in Sponsor's sole discretion. EACH ENTRANT ACKNOWLEDGES THAT IF HE/SHE IS CHOSEN AS A WINNER, CERTAIN OF HIS/HER IDENTIFYING INFORMATION MAY BE DISCLOSED TO THIRD PARTIES AT LEAST AS REQUIRED BY LAW INCLUDING, WITHOUT LIMITATION, ON THE WINNERS LIST.
